New State of Washington Legislation Designed to Combat Hazing¹

In March 2022, Governor Inslee signed into law legislation specifically designed to require each public and private institution of higher education in the State of Washington, and each Fraternity and Sorority having a chapter at these institutions, to address both on and off campus hazing. The new law (known as "Sam's Law") requires a number of new administrative or enhanced steps and procedures. (Parallel legislation designed to increase the penalties and statute of limitations for hazing did not pass.)

Sam's Law is named in honor of Sam Martinez, a 19-year-old student at WSU and pledge of Alpha Tau Omega Fraternity. He died on November 19, 2019, from acute alcohol poisoning after an event titled "Big-Little Night" the evening before his death. Sam's parents were instrumental in bringing Sam's Law to fruition, and rightfully asserted that deaths such as Sam's were (are) avoidable — and unacceptable. Thus, and most importantly, the issues that prompted the legislative action to draft and approve Sam's Law — and Governor Inslee's signing the legislation into law — are relevant and germane to the current and future wellbeing of Washington Alpha and Greek Life, and the students we bring into membership.

Specifically, Sam's Law requires higher education institutions to:

- 1. Prohibit hazing off campus, as well as on campus, in its code of conduct.
- Provide students with an educational program on hazing and the dangers of and prohibition on hazing as
 part of new student orientation sessions, including information regarding hazing awareness, prevention,
 intervention, and the institution's policy on hazing. The educational program must be posted on each
 institution's public website for parents, legal guardians, and volunteers to view.
- Create institutional materials on student rights and responsibilities to be given to student organizations, athletic teams, or living groups, either electronically or in hard copy form, that include a statement on the institution's anti-hazing policy and on the dangers of hazing.
- 4. Establish a hazing prevention committee to promote and address hazing prevention. Fifty percent of the committee positions must include students currently attending the higher education institution with at least one position filled by a student from a student organization, athletic team, or living group. The other fifty percent of the committee positions should include at least one faculty or staff member and one parent or legal guardian of a student currently enrolled at the institution.
- Maintain and publicly report actual findings of violations by any student organization, athletic team, or living group of the public or private institution of higher education's code of conduct, anti-hazing policies, or state or federal laws relating to hazing or offenses related to alcohol, drugs, sexual assault, or physical assault.
- Provide hazing prevention education on the signs and dangers of hazing as well as the institution's prohibition on hazing to employees, including student employees, either in person or electronically.
- 7. Ensure that any person who witnesses hazing or has reasonable cause to believe hazing has occurred or will occur and makes a report in good faith is not sanctioned or punished for the violation of hazing unless the person is directly engaged in the planning, directing, or act of reported hazing.

Relatedly, Sam's Law requires each Fraternity and Sorority operating affiliated chapters at institutions of higher education (this means Washington Alpha) to undertake the following:

- Notify the public or private institution of higher education before chartering, rechartering, opening, or reopening a local chapter or operating at the public or private institution of higher education.
- 2. Notify the public or private institution of higher education when the organization instigates an investigation of a local chapter at the public or private institution of higher education for hazing or other activity that includes an element of hazing, such as furnishing alcohol to minors.
- Provide the results of such investigation and a copy of the full findings report to the public or private institution of higher education's student conduct office.
- 4. Certify in writing and provide weblinks to any public or private institution at which a chapter is seeking to obtain or maintain recognition, showing that the landing pages of all websites owned or maintained by the local chapter contain a full list for the previous five years of all findings of violations of anti-hazing policies, state or federal laws relating to hazing, alcohol, drugs, sexual assault, or physical assault, or the institution's code of conduct against the local chapter. State of the Chapter

From the Desk of GP Grant Conrad

Chapter Status

For my concluding report on the state of Washington Alpha, I am proud to say that chapter operations have returned to complete normalcy for the first time since my freshman fall quarter in 2019. The first "real" quarter appeared in Spring 2022, when classes were fully in-person along with an optional mask mandate. However, this fall, with the help of our stellar

new pledge class, Phi Kappa Psi finally feels how it should. This will be my final report for Washington Alpha as I pass the reigns to **Christian Min '21**, the newly elected President of Phi Kappa Psi, as the chapter transitions into 2023.

Every fall, Washington Alpha has the honor of welcoming a new pledge class, and this year was certainly no exception. Our 2022 rush chairmen, Cole Roddy '20, Will Crockett '20, Devon Castro '20, and Alexander Au '21, managed to sign 23 new members to our fall pledge class with two more already signed for the winter. Despite a rough recruitment year for the overall Greek system (sororities included), Washington Alpha has performed better than many other fraternities. I've had the honor of watching these new members join our brotherhood, learn our traditions, and fully realize the benefits of not only joining a fraternity but of joining Washington Alpha. With these numbers being higher than our previous pledge class of 19, I believe this chapter is on track to grow larger and maintain itself in an age of never-ending challenges and changes for fraternities and Greek life in general. Our chapter has maintained good standing with the University and IFC, as a result of our adherence to and respect for its rules. At the time of writing this report, Washington Alpha is transitioning, as the 2021 pledge class steps up into the majority of chapter positions. The 2022 pledge class is close behind, as the class members learn the ropes and enter their second quarter in the house. *Here's a look at what we've been up to:*

Philanthropy

In spring 2022, we hosted our annual Phi Psi Spike competition (post-COVID) when sororities compete in a volleyball tournament to raise money for the American Foundation for Suicide Prevention (AFSP). Our four-day volleyball tournament and ice cream social yielded more than \$1,000 toward our cause, with Alpha Phi winning the tournament.

For Suicide Awareness month in September, we challenged all of the brothers to raise money for the AFSP. Through bingo-style donation cards on social media and asking friends, family, and alumni members, we raised an additional \$1,300 before school even started in the fall 2022 quarter.

Additionally, we cannot be more excited about our weeklong philanthropy event, Phi Psi 500, that will be hosted in winter 2023. It will focus on raising funds for the AFSP through entertaining events such as "Pie-A-Phi-Psi," therapy dogs, a Krispy Kreme feed, and a sorority basketball tournament. Our current philanthropy chairmen, Justin Phan '21, Austin Niemi '21,

and Charlie Brady '21, have been instrumental in organizing events and helping brothers balance schoolwork and social life with Washington Alpha's commitment to service.

As always, suicide prevention will remain the cornerstone of our philanthropy, with our late brother **Anthony Newsome-Moffa '17-1852** in our hearts along with all brothers of Phi Kappa Psi who struggle with mental health.

Academics

We saw a slight drop in our overall chapter GPA with a 3.57 average for spring 2022 (it was 3.64 the prior winter quarter). This drop reflects the changes from "extraordinary circumstance quarters" granted by the University, back to regular grading. Students were able to S/NS any class during that time without penalty, so many chose to do this to remove sub-par grades impacted by virtual learning from their overall GPA. However, this 3.57 still outpaced the all-men's average GPA, along with the average IFC GPA, with a majority of our members making the Dean's List. Any GPA drop is still a concern to us so, with the leadership of our Academics Chairman Cameron Smith '20, we've looked to build up from this through more frequent grade check-ins, encouraged study hours on campus, and academic resources such as mentors and tips to balance social life and other commitments with school. We expect to post a strong overall GPA at fall quarter's end. On the career and professional development side, Andrew Wolf '21 has assisted our new and current members by ensuring we all have proper resumes, LinkedIn profiles, and involvement in the endless clubs across the UW campus. He has helped individuals through advice and questions regarding career paths and internships. Also, he has made a Washington Alpha LinkedIn page for brothers to connect with and build our alumni network. All alumni of Washington Alpha are encouraged to connect!

Grand Arch Council 2022

Connor Fink '21 and Austin Niemi '21 spent a week in summer 2022 at the Grand Arch Council (the national governing body of Phi Kappa Psi) in Indianapolis, Indiana. They had the opportunity to get involved and even vote in national committees, connect with hundreds of alumni and undergrads across the country, and see how Phi Kappa Psi runs on the national level. They even had the opportunity to be involved in changing some of the National Fraternity's bylaws. Their favorite parts included the elegant steak dinners downtown, and spending time with Phi Psis from different chapters at the hotel.

Most important, however, was Washington Alpha's national recognition. For the first time in years, Washington Alpha brought home some hardware! We won the Outstanding House Corporation Award,

Morris L. Bangham, '56-671, is deceased, according to the family. He had resided in Rockville, Maryland.

Gerald D. "Gary" Mapes, '56-694, of Othello, Washington, died December 12, 2022, according to his brother, John L. Mapes ['61-774]. Stan Kohagen ['55-657] wrote: "Gary excelled in track. He was a state 100-yard dash champion in high school. At the UW, he ran the fastest 100-yard dash in 9.2 seconds — the fastest in the U.S. at that time. He beat Dean Derby, a UW football and track star, and finished with a big smile!" Paul Wineman ['55-669] was Gary's Big Brother at Washington Alpha, and the two of them stayed in contact through the years. Paul wrote that Gary worked hard, maintained a good GPA, and was an exceptional track star who set the 100-yard dash record at the University. He enjoyed an active social life, but was more on the quiet side. He will be sorely missed by all the brothers who knew him."

Steven M. Block, '61-776, of Seabeck, Washington, died October 3, 2021. His family wrote: "Steve lived a grateful life. Some say he lived four lives in one. He worked hard and played hard. Not a minute was wasted. His generosity overflowed!!" He grew up in Madison Park on Lake Washington, the child of Czech parents who were refugees from the Holocaust. He graduated from the University of Washington in 1964. Edward A. Lawrence ['61-782] wrote: "Steve was a great person with a wonderful family. He was always very supportive of the fraternity and tried to keep in contact with the brothers of Washington Alpha. When he and I were freshmen, he told me that I should do some exercise every day. So he had me throw a football in the afternoon after classes. For the last many decades, he would get me out on the tennis court even when I was tired. I miss him." Steve worked for his father until he bought the business, Plymouth Poultry, in 1974. He treated his employees like extended family members and made many lifelong friends. He served in the U.S. Coast Guard. He leaves behind his wife of almost 47 years, Betty; daughter, Nikki; son, Nate; and six grandchildren. All shared in his love of fishing, crabbing, shrimping, swimming, camping, and skiing yearly in Sun Valley, as well as locally at Crystal Mountain. Steve and Betty also biked and played tennis and pickleball for over 40 years. Jewish tradition says, "May his memory be a blessing.'

Thomas E. Swapp, '66-894, died September 17, 2022, at his home in Anacortes, Washington. He was 74. He graduated from the University of Washington with a Bachelor of Science degree, earned his master's degree in Biology at Central Washington University,

and his teaching degree at Western Washington University. After receiving his teaching degree, Tom began teaching at Anacortes Middle School, where he spent all but one year of his teaching career. As a 7th grade bloc teacher, he combined high expectations with a sense of humor, and created an environment in which students could thrive. Tom was a learned man. In his pursuit for knowledge, he read countless books. He is well known for his long coaching career. As the only



softball coach in the history of Anacortes High School, Coach Swapp spent 42 years leading the Seahawks' softball program, and has more career victories than any softball coach in Washington state history. He is a member of the Washington softball coaches' hall of fame, and led his team to a state championship in 1994. More important than all the victories, however, was the relationship he had with his players. As one of his former players wrote: "I hope you realize the wonderful memories you created and how many students' and players' lives you helped shape. The powerful influence you had on so many of us is incomprehensible. If everyone had a Mr. Swapp in their lives, the world would be a better place." Tom was an avid sports fan, and he shared many memories with friends and family at Mariners and UW Huskies

games. He was an especially proud fan of his grandchildren, and a nurturing grandfather. He is survived by his wife of 31 years, Peggy; his son, Patrick; stepchildren, Christopher and Lindsey Gerwels; and three grandchildren. He also leaves behind many friendships forged from a career in education and in coaching, along with countless memories carried in the minds of thousands of students and athletes he taught and coached.

Thomas R. Hargan, Jr., '95-1478, of Auburn, Washington, died June 15, 2018. He earned a BA degree at the University of Washington in 1998. He went on to Seattle University School of Law and earned his JD degree, graduating magna cum laude in May 2001, and was admitted to the Washington State Bar Association in 2001. From July of 2000 through April of 2003, Tom served as a Deputy Prosecutor in several Pierce County District Courts. In 2003, he left the Pierce County

Prosecutor's Office for the law firm of Sampson & Wilson, Inc., PS. He served as the prosecutor for the cities of Buckley and Normandy Park, and also served as an assistant to the City Attorney for Buckley, Normandy Park, and Covington. In September of 2004, Tom was brought in-house with the city of Covington, where he served as the Assistant City Attorney and Prosecutor, before being promoted to City Attorney



and Prosecutor. In November 2006, he opened the Law Offices of Thomas R. Hargan with a focus on municipal law and prosecution. Since opening his law office, Tom served as prosecutor for the cities of Covington, Maple Valley, and Buckley, and as a conflict prosecutor for the cities of Enumclaw, Algona, Pacific, and Black Diamond. Tom also served as the interim City Attorney and backup City Attorney for the cities of Maple Valley, Buckley, and Snoqualmie. He is survived by his wife, Julie Johnson Hargan; his children, Sophia, Sydney, and Oliver; and his parents, Thomas Sr. and Kaye.
